- 1) The Candidate shall join the training course of his/her own risk and that he/she shall not hold PPDC, Meerut responsible for accident /untoward incident during the training period.
- 2) Selected candidate shall strictly abide by the instructions of the Principal Director/Training Incharge of the Centre.

- 4) Principal Director, PPDC, Meerut may terminate the training of any candidate without assigning any reason whatsoever.
